House rules

You agree to the following house rules upon booking:

- There is a strict noise policy at both properties. No noise after 10pm, if there is a noise complaint
 from neighbours we will call to resolve, if it continues we do have remote access to the power
 supply, which may be turned off, also occupancy may be terminated without refund
 and loss of bond.
- Extra visitors to the house are not permitted under any circumstances without permission from owner. CCTV to external entrances complies with privacy regulations.
- Strictly no smoking inside, no cigarette butts to be left in garden (Ash trays provided)
- Do not rearrange furnishings
- Tank water is in use. Water usage is monitored and excessive water usage costs will be deducted from the bond.
- A reasonable amount of firewood is supplied for your stay, additional firewood can be purchased at your own cost, a list of local suppliers are in the guest manual.
- The pizza oven is not available to guests as it requires an experienced operator.

Cleaning & check out

Your rate includes a professional clean and all linen laundered at the end of your stay. We ask that you leave the house respectfully clean and tidy and in order as presented, we expect:

- Bins to be emptied
- Rubbish bins placed on the roadside (rubbish collection Monday morning)
- BBQ and outdoor kitchen to be left clean
- Turn off all heating/cooling, lights and appliances

Bond

The bond is fully refundable but monies maybe deducted for the following:

- Unplugging audio visual leads or re-programming devices \$100 min
- To replace remote controls or house keys \$100 min
